## Historic Royal Palaces

However, we also want to ensure that any negative impacts, such as increased traffic and disruption to local communities is minimised. If you are planning on organising an event utilising Barge Walk, please get in touch so that we can work with you to help you have a successful event and help to look after our special site at the same time.

Hampton Court Palace attracts over 1 million visitors each year and these visitors are a priority to us as a charity, which receives no funding from the government. In addition to this, we host an incredibly large number of events annually across the entire estate, both our own and those operated by external partners. As such, it is paramount that we balance these events alongside our visitors, and ensure any additional activity will not impact them in a negative way. We also have to consider those individuals who like to enjoy Barge Walk as a public space – and ensure that organised activity in this area does not limit this enjoyment.

It is important that Historic Royal Palaces is contacted as early as possible whilst there is still flexibility in your plans. Organised events do not have permission to use public rights of way – and the use of Barge Walk for these events cannot be guaranteed. Please contact our Event-coordinator who will consult the key stakeholders for Historic Royal Palaces as necessary.

To cover our administration costs all approved applications will incur a £50+VAT fee.

## Terms and conditions of Barge Walk for public events

Permission is given on condition that:

- a) All participants and officials keep to the agreed course as detailed in the application form approved by Historic Royal Palaces.
- b) No annoyance is caused to, nor is interference made of general public persons using Barge Walk.
- c) You will leave Barge Walk in a clean and tidy condition or pay compensation to Historic Royal Palaces in respect of any damage which may be caused to property belonging to or under the control of Historic Royal Palaces, arising from your use of Barge Walk. Please advise your participants not to leave any litter on-site.
- d) You will indemnify Historic Royal Palaces against all claims and proceedings in respect of personal injury (including death), loss of or damage to property arising out of your use of Barge Walk.
- e) Any instruction which may be given by a staff member of Historic Royal Palace is complied with.
- f) All site regulations are observed your attention is drawn particularly to those <u>prohibiting the collection or soliciting of money (i.e.</u> donations or subscriptions) the selling or distribution of materials (e.g. <u>pamphlets, programmes or newspapers</u>), the exhibition of notices, advertisements or other written or pictorial matter (e.g. banners or slogans) and the playing of musical instruments. No refreshments may be sold on-site.
- g) No vehicles to come on-site, except emergency vehicles.
- h) Sufficient public liability insurance is in place, and full risk assessments and event plans are prepared. The primary duty of care for the participants rests with the organiser of the event and so it is essential that you prepare an event management plan and a full risk assessment. Historic Royal Palaces does not provide assistance with these.
- i) Full payment of the £50+VAT application fee is made prior to the event date.
- j) Details on the application form remain accurate and correct.
- k) Advertising for the event refrains from associating the activity with either Historic Royal Palaces or Hampton Court Palace and avoids using imagery that promotes an association.
