### Foreword

#### Dr Laura Tompkins, Research Lead

It is with great pride that I introduce the 2024 Annual Research Report for Historic Royal Palaces (HRP) for the academic year October 2023 – September 2024. This year's report offers a rich account of our research activities, reflecting the scope and ambition of our efforts to uncover new insights about the historic sites we care for and to bring their stories to life for the widest possible audiences.

At the heart of HRP's Research Strategy is our commitment to fostering inclusive and diverse histories. This guiding principle has shaped many of the projects showcased in this report, from the Untold Lives exhibition at Kensington Palace, which illuminated the hidden stories of royal servants, to the work of the Queer Heritage and Collections Network, a vital initiative bringing LGBTQ+ histories to the fore. Through our collaborative doctoral partnerships and community-focused projects, we continue to amplify voices from the past that have often been overlooked, ensuring our research reflects the complexity and richness of the histories we share.

The 2023–2024 period has also seen us deepen our commitment to advancing heritage science, championing conservation innovation, and addressing contemporary challenges. The REVEAL project exemplifies how our research not only enhances the care of our collections but also creates opportunities for broader public engagement with the scientific processes that underpin our work. Such initiatives ensure HRP remains at the forefront of research that blends historical scholarship with cuttingedge methodologies. Collaboration remains key to our success. By working closely with universities, fellow cultural heritage organisations, and industry, we are delivering projects that not only expand scholarly understanding but also directly inform how we engage with visitors, from the reimagined Wolsey Rooms at Hampton Court Palace to sensory history trails at the Tower of London. These partnerships are vital to our ability to connect diverse audiences with the rich stories embedded in our palaces.

Our research also strengthens HRP's reputation as a trusted voice, delivered through public engagement activities such as podcasts, blogs, and social media. This is vital as we strive to reach further and engage more audiences than ever before over the coming years.

I am particularly proud of how our research programmes support the next generation of historians, curators, and heritage scientists. Our doctoral and early-career researchers continue to break new ground and bring fresh perspectives to our work through original, indepth studies, which underpin HRP's strategic aim to be a 'Charity for Everyone'.

This report is a testament to the dedication, expertise, and creativity of everyone involved in our research activities. I am deeply grateful to my colleagues for their tireless commitment to ensuring that HRP remains a centre of excellence in research, and our partners and funders for supporting this work.

As we look ahead to 2024-2025, we remain committed to generating and delivering new research that supports the HRP Research Strategy, illuminating diverse histories, engaging communities, and shaping the future of heritage scholarship.



## Highlights

### 2023-2024

2023-2024 has been an incredibly active period of research for Historic Royal Palaces (HRP).

Research highlights include the ongoing activities as part of the AHRC-funded 'Henry on Tour' project, led by Professor Anthony Musson, which aims to map Henry VIII's complete progress itinerary and engage with local communities. Through additional funding from the AHRC, the Society of Antiquaries, and South Downs National Park Authority, further public engagement and community work has been made possible, including a community dig at Petworth and a re-enactment of a progress welcome at Exeter in the summer of 2024.

Dr Constantina Vlachou Mogire has also been successfully awarded funding from the AHRC for the RICHeS REVEAL project, which will deliver a step change in HRP's physical and digital storage facilities as well as staff resources for cataloguing the large number of our scientific sample collections and data. This follows closely from the recent £1m AHRC World Class Labs Capability for Collections (CapCo) fund, which allowed HRP to upgrade the heritage science facilities. In a recent report conducted by BOP Consulting, which evaluated the impact of the programme, HRP was selected to feature as one of the five case studies – a testament to the expansion and development of HRP's scientific research.

HRP's major exhibitions in 2023-2024 have also generated significant research and public outputs. *Untold Lives: A Palace at Work* at Kensington Palace, curated by Dr Mishka Sinha and Sebastian Edwards, showcased the oftenoverlooked lives of palace servants in the long eighteenth century. In addition, the re-opening of the Wolsey Rooms at Hampton Court Palace and the accompanying exhibition, *The Tudor World*, curated by Brett Dolman, has generated new research into the global context and material culture of the Tudor Court.

During the summer of 2024, Matthew Storey and Kaori Motaung travelled to Japan for two weeks in order conduct further research on the Japanese coatee (taireifuku) in the Royal Ceremonial Dress Collection. During their visit, as well as examining similar items in Japanese collections, they also delivered multiple talks, lectures, and workshops with colleagues in Japan. This invaluable knowledge exchange was made possible as a result of funding from the Daiwa Foundation as well as a generous donation from HRP Patron, John Harding.

HRP is proud to further our research through collaborations with our partners in higher education and the heritage sector. As a founding partner of the Queer Heritage Collections Network, led by the Research Centre for Museums and Galleries, University of Leicester, HRP continues to support GLAM organisations in bringing queer histories to the fore in their public programming. In addition, as part of HRP's collaboration with the University of Oxford, there has been further research on the history of violence and imprisonment at the Tower of London. HRP's partnership with the University of Exeter on the ENLIVEN project, which aimed to engage older people living with dementia with nature, has resulted in a sensory history trail at the Tower and has been selected as a case study for the overall project. Partnering with colleagues at Royal Museums Greenwich, HRP conservators have engaged in knowledge exchange activities around the history and conservation of the Solebay tapestries.

Finally, Historic Royal Palaces continues to support the next generation of professionals through its educational activities. The MA in Heritage Management, led by Professor John Davis in collaboration with Queen Mary University London, continues to expand. HRP's cohort of collaborative doctoral award students also continues to grow, and our students uncover valuable insights about the history of our palaces and the people who inhabited them.

#### Henry VIII on Tour: Landscapes, Communities & Performance

Grant: AHRC Standard Project Grant

**Project team:** Anthony Musson (PL, HRP), John Cooper (PcL, University of York), Katherine Giles (PcL, University of York), and Magnus Williamson (PcL, Newcastle University).

**About**: The aim of this project is to compile Henry VIII's itinerary for his complete reign, exploring themes of kingship/queenship as well as the performance, architecture/archaeology and logistics of his progresses. The project includes research and public engagement activities with various partners and collaborators that also feed into the legacy strand.

Award duration: November 2022 – October 2025.

Award total: £990,496 (£792,397 received by HRP)

#### Henry VIII on Tour at Petworth Park

Grant: South Downs National Park Authority

**About**: This grant assisted with the public engagement for an archaeological dig at Petworth House and promoted inclusivity through targeted groups of young people.

#### Building the White Tower: A Historic and Petrological Analysis of the Flamsteed Tower Stairs

**About**: This grant will allow for additional research and the publication of the results of archaeological recording undertaken during the White Tower Flamsteed Stairs Project.

Award total: £11,860.

#### Japanese Court Dress Research

Grant: Daiwa Foundation Small Grant

Project team: Matthew Storey and Kaori Motaung (PLs, HRP)

**About**: A research project on Japanese court dress (taireifuku) to support the conservation and interpretation of an example in the HRP collection. The funding allowed Matthew Storey and Kaori Motaung to take a research trip to Japan to research taireifuku in museum collections, and to exchange knowledge with Japanese experts. Outputs for the research include the display of the object at Kensington Palace in 2025 and supporting the associated community engagement project. Research in Japan was undertaken with Monica Bethe and Michiyo Katsura of the Medieval Japanese Studies Institute in Kyoto.

#### REsearch Vault for HEritAge Science CoLlections (REVEAL)

**About**: The REVEAL project will deliver a step change in HRP's physical and digital storage facilities as well as staff resources for cataloguing the large number of our scientific sample collections and data. This will provide an essential platform to conduct and facilitate excellent research. This award is an acknowledgement of HRP's leading role contributing as a centre of excellence in the RICHeS national network of facilities, collections, and expertise for heritage science research.

#### Award duration: June 2024 – April 2026

Award total: £434,000.



#### Historic Royal Palaces Hyperspectral Imaging Upgrade

**Grant:** Research and Innovation Organisations (RIO) Infrastructure Fund Grant, Department for Science Innovation and Technology (DSIT)

Collaborators: English Heritage, University College London

**About**: This grant, led by Dr Constantina Vlachou-Mogire, allowed us to extend HRP's capabilities for the hyperspectral imaging scanner and develop a wide range of novel applications including assessing the condition of historic tapestries or analysing salts on historic buildings.

Award total: £200,000.

#### Henry on Tour: Curating the Musical Soundscape

Grant: AHRC Follow-On Funding for Impact and Engagement

**Project team:** Led by Professor Anthony Musson (HRP) in partnership with: Historic Houses, Delphian Records, English Heritage, West Horsley Place, Acton Court, His Majesty's Sagbutts and Cornetts

**About**: Building on the research generated from *Henry on Tour*, this project, if successful, would seek to re-engage audiences in heritage sites that were places of hospitality and entertainment when Henry VIII was on progress, by developing a 'progress package' of audio, visual, and textual material for sites.

#### Anticipated award dates: February 2025 – February 2026

**About**: The QHCN, of which HRP is a founding member, helps organisations across the GLAM sector to bring LGBTQ+ histories and themes to the fore in their public programming. In 2023, the QHCN led a successful application to Arts Council England, marking a step change in the scale and ambition of the network.

## (Hi)stories of Violence: Myth-Making, Imprisonment and the Cultural Identity of the Tower of London.

**Project Team:** Led by the University of Oxford, in collaboration with HRP (Dr Alden Gregory and Dr Laura Tompkins) and the Royal Armouries

**About**: This joint project between HRP, Royal Armouries, and the University of Oxford will study how histories of violence have been conceptualised in the cultural imagination in relation to the Tower of London from the Middle Ages to the twentieth century.

**Award duration:** Funding awarded in summer 2024; project to take place between September 2024 – September 2025.

Award total: £56,474.80.

#### Writing a New History of Treason

Grant: AHRC Research Network

**Project team:** Led by Professor Mark Cornwall (University of Southampton) and Dr André Krischer (University of Freiburg), with Historic Royal Palaces as a Project Partner (Dr Alden Gregory and Dr Laura Tompkins).

**About:** This project aims to develop a new conceptual and critical approach to the history of treason across time periods and geographical regions, creating an interdisciplinary and



international network of scholars to exchange legal, linguistic, and philosophical approaches to the subject of treason.

#### Hosting Henry VIII at West Horsley Place and Powderham Castle

**Project team**: Led by the University of Exeter, in partnership with HRP (Professor Anthony Musson), West Horsley Place and Powderham Castle

**About:** This project focused on reenacting a Civic Welcome at Exeter and living history events exhibitions staged at Exeter Cathedral, Exeter Guildhall, St Nicholas' Priory, Tuckers' Hall, West Horsley Place and Powderham Castle. This included performance of Tudor music and realising Courtenay family clothing (Wimbledon College of Arts) and bow and quiver (Black Arrows Company) from archival sources in The National Archives.

**Award total:** £15,000 awarded from University of Exeter Outreach and Innovation Platform Fund, and £17,170 and £4425 from the AHRC Impact Accelerator Fund

#### **ENLIVEN**

Grant: ENLIVEN Small Grants Scheme

**Project team**: Led by the University of Exeter, in partnership with the HRP Community Partnerships Team (led by Kim Klug)

**About**: This award was to deliver and evaluate workshops that engage older people with dementia and cognitive impairment with nature. Focusing on the moat at the Tower of London, this activity resulted in a sensory/history trail developed in collaboration with participants that is now available for all visitors to use and engage more deeply with nature in the moat. The project team presented at the ENLIVEN research report launch event, which was held at the Tower of London, January 2024. The project also featured as a case study in ENLIVEN's final report for the funding scheme.

#### **Beyond** Notability

Grant: AHRC Follow-On Funding for Impact and Engagement

**Project team:** Led by Dr Amara Thornton, Institute of Classical Studies (School of Advanced Study, University of London)

**About**: If successful this project will deliver a package of impact work with HRP, building upon the original project which created a database of women working in archaeology, history, and heritage in Britain, 1870-1950. The proposed activities will consist of a workshop for HRP staff on the creation of the database; research on two Hampton Court grace and favour residents who feature in the database; research on Hampton Court as a location for University Extension courses; internal research dissemination and external public engagement outputs.

Anticipated award dates: If successful, the project will commence in March to April 2025.

In November 2024, we were informed that the outcome of this application was unsuccessful.

#### Activating Research in Conservation and Heritage (ARCH)

Grant: AHRC Doctoral Focal Award

**Project team**: Led by the Courtauld Institute of Art, co-led by Dr Constantina Vlachou-Mogire (HRP), King's College London, University of Cambridge, The National Trust, and the Victoria and Albert Museum. Other project partners include the British Library, Cambridge University Library, Chiddingstone Castle, Churches Conservation Trust, Church of England Cathedral and Church Buildings Department, The Fitzwilliam Museum, the Getty Conservation Institute, the International Institute of Conservation, Lambeth Palace Library, and Historic England.

**About**: ARCH aims to produce the next generation of conservation and heritage leaders, equipping them with the specialist material and cultural training, interdisciplinary skills, and sector insight to lead a paradigm shift in how we understand, protect, manage, and share cultural heritage. Advanced research in conservation, heritage studies, art history, digital



humanities, and the physical sciences, will address conservation and heritage challenges and bring creative economy benefits in an era of cultural, technological, and environmental change.

#### Digital Skills for Curation and Conservation of Cultural Heritage (DiSCC)

Grant: AHRC Doctoral Focal Award

**Project team**: Led by Imperial College, co-led by the City & Guilds of London Art School and West Dean College of Arts, Design, Craft & Conservation. HRP, alongside other heritage organisations, will act as a Project Partner.

**About**: The DiSCC Centre aims to bring together digital skills, science, engineering, and cultural heritage to train the next generation of heritage scientists and conservators. The arts and heritage sector has an urgent need for people with digital skills and science and technology research training, as well as traditional conservation & heritage knowledge. Imperial provides excellence in PhD supervision, expertise in digital skills (including digital twins, modelling, AI), and cutting-edge science and engineering techniques. City & Guilds of London Art School provides excellence in conservation training and application of analytical techniques to practical conservation applications. A range of heritage partners will provide students with practical training and experience of conservation challenges.

#### Solebay Tapestry Research with Royal Museums Greenwich

Collaboration between HRP and the textile conservators and curators from RMG focussing on the history of the Solebay tapestries. RMG visited HCP for a day to look at the Solebay tapestries in our care and to compare them with the one they have in their collection. HRP conservators visited RMG to see their Solebay in return and a date was set for a symposium.

### **Research Events**

#### 'Weaving Waves: The History and Conservation of Maritime Tapestries', Symposium at Royal Maritime Museum Greenwich, 12 January 2024

One day symposium that focused on the history and display of maritime tapestries. This was run in conjunction with the Willem Van de Velde marine artist exhibition that was held at the maritime museum. The afternoon session focussed on the conservation of Solebay tapestries of which HRP care for five.

## National Heritage Science Forum (NHSF) Climate Emergency 'Deep Dive' meeting, January 2024.

This deep dive event addressed the climate emergency societal challenge by bringing people together from different communities of interest to discuss the state of the challenge in 2024, the work that the heritage science sector is already doing to address the climate emergency, and gaps to be addressed by future research. This was organised and chaired by Dr Constantina Vlachou-Mogire.

#### Presenting and interpreting the difficult histories of prisoners and punishment, Tower of London, 9 February 2024

In association with the Oxford-funded Knowledge Exchange Fellowship, 'Torture and Execution at the Tower of London', this workshop brought together approx. 25 historians and curators from HRP, Royal Armouries, universities, and other museums to consider how best to present the histories of torture and imprisonment in the Tower conscientiously to a large and diverse audience of all ages.

#### The Music & Liturgy of the Progresses, Christchurch Priory, 1-3 May 2024

As part of the AHRC-funded 'Henry on Tour' project, this workshop explored the hosting of Henry VIII in monastic houses and bishop's palaces and questions about the locations and nature of musical and liturgical ceremonial while on progress.

#### Making the Middle Ages Relevant Today: Collaborations in Times of Crisis, Leeds International Medieval Congress, 3 July 2024

A roundtable discussion on what can medieval history contribute to contemporary issues in heritage and policy? The session was co-organised by HRP and Oxford, featured a number of invited speakers from universities across England and Scotland, and was chaired by HRP Research Lead, Dr Laura Tompkins.






